

No member of the committee will be eligible for induction while serving on the selection committee.

Criteria for nomination

Each candidate must receive an average of more than 3 in the matrices mentioned below demonstrating Christ-like character, citizenship, success, and leadership during and after his/her affiliation with International Christian School.



This will be determined not only by the data provided by the nominee but by the committee and must meet the guidelines in all of the following categories.

Athletes

1. The nominee must be a graduate of The International Christian School.
2. Nominees into The International Christian School Athletic Hall of Fame shall have graduated a minimum of four years prior to being inducted.
3. No member of the committee will be eligible for induction while serving on the committee.

Coaches

1. Three years must elapse after completion of their tenure as a coach before consideration is given for selection.
2. Nominees must have coached for a minimum of 4 years at ICS.

Team Induction

1. For those Teams who have made an outstanding contribution to the sporting success of the International Christian School.
2. Final regular season records, post season appearances and post season success will be considered as priority rationale for induction.
3. Unique and one off achievements will be particularly taken into account as team inductions would not be a common occurrence.

*The Selections Committee reserves the right to make exceptions to any of these guidelines for special circumstances.

Size of each class: After an initial induction of 4, every 2 years thereafter, there will be a maximum of 3 inductees/teams.

How to nominate

In order to maintain the integrity of the Hall of Fame the following criteria have been established for nominations. Nominees must exemplify the highest standards of sportsmanship, ethical conduct and Christ-like character. All candidates will be judged on their significant and or long-term contributions to International Christian Schools athletics.



Nomination Procedure

1. Inductees may be nominated by;

- a. The Selection Committee
- b. Current or former coach or administration.
- c. An alumnus athlete.

2. Nomination Form

- a. All entries must be submitted on the International Christian School Hall of Fame nomination form (links below). Nomination forms must be filled out accurately and completely for consideration.
- b. Forms shall be available through the International Christian School website.
- c. The nomination form shall be completed and submitted to the Athletic Director by May 1st for the candidate to be considered for induction in the following school year. All nominations received must contain active and current addresses and contact information for the nominee.
- d. If the nominator cannot fill out the nomination form in its entirety please provide information of other individuals who may be able to do so.

3. Terms of Nomination

- a. Following the initial nomination, a candidate shall remain eligible for induction for the following five years. The Athletic Director will keep the nomination forms and information on file. After five years a person may be re-nominated.

4. Process after Nomination

- a. The Athletics Director will gather background information on the nominated person/team.
- b. The Athletics Director will contact previous coaches and teammates as well as teachers to gather relevant information that will assist with the selection process.
- c. Notice will be taken of the number of nominations the individual receives.
- d. This process will also include reaching out to previous coaches and staff who are no longer serving at ICS.
- e. Once significant supporting information has been gathered, the Athletics Director will bring nominated athletes to be discussed with the selection committee using the following hall of fame matrices.

*ACSC title is revered in higher esteem by both players and coaches and thus a higher level of achievement is recognised by winning this in comparison to the ISSFHK, even though in particular sports this may not be of as higher quality of play. For sports that do not compete in the ACSC the highest an athlete may achieve is a level 2. We recognise that this puts an advantage to those students who are part of our 3 GOLD level sports.

Team criteria;

This is a very unique and uncommon award only for a team to be inducted they need to accomplish a one off sporting achievement that is very unlikely to ever be replicated again. The committee will need to be in agreement with this particular achievement.

This achievement would have to be one such award that not only is deemed extremely difficult and challenging to occur for future ICS teams but also not replicated by other school teams within the organization or league.

Nominator needs to show and document what this achievement was and the committee must all be in agreement not only of the worthiness of the team in question but that the achievement was worthy.
